Equitas Holdings Limited (erstwhile Promoter) stands dissolved in pursuance of Scheme of Amalgamation between Equitas Holdings Limited (Transferor Company/Amalgamating Company/EHL) and Equitas Small Finance Bank Limited (Transferee Company/Amalgamated Company/ESFBL) and their respective shareholders approved by the Hon'ble National Company Law Tribunal, Division Bench II, Chennai vide its order dated January 12, 2023. Consequently, 93,39,43,363 equity shares of Equitas Small Finance Bank Limited which were held by Equitas Holdings Limited (Erstwhile Promoter) have been cancelled on account of cross holdings in pursuance of the approved Scheme.
