**Sub: Grant of Employee Stock Options under ESFB Employee Stock Option Scheme, 2019**

Pursuant to the authority granted by the Shareholders vide Resolution passed at the EGM held on November 22, 2019, the Nomination & Remuneration Committee (NRC) of the Board of Directors has approved grant of 14,37,208 (Fourteen Lakhs Thirty-Seven Thousand Two Hundred and Eight) stock options to the Eligible Employees at an exercise price of Rs.49/- (Rupees Forty Nine only) per share. The grant shall be governed by the terms and conditions of ESFB Employee Stock Option Scheme, 2019. The Scheme is in compliance with SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021.
